

## SADDLEBROOKE LADY NINERS GENERAL MEETING

October 15, 2024

President Cheryl Hays called the meeting to order at 10:15 AM. She welcomed Lady Niners and extended special thanks to Kat Danner for arranging brunch, Vicki Long for providing Halloween decorations, and Food & Beverage for their service.

**Treasurer's Report:** Sandy Wagoner reported a beginning October balance of \$15,242.36. Additional 2024 expenses will include weekly sweeps and trophies to be awarded at our December luncheon.

**Membership:** LeAnn Ellingson, Vice President, reported that current active membership is slightly below 100, and our goal is to increase participation in 2025. LeAnn reminded members of our Guest policy, which enables us to invite prospective members to play with our League up to two times per year before they decide to join the Niners.

Annual dues of \$105 must be paid before January 1<sup>st</sup>, and checks may be deposited any time before that in the Lady Niners Drawer in the Pro Shop. New members joining in 2025 must also submit a completed membership application with their dues payment. **Ringer Board:** C. Hays reported for Theresa Mares regarding the 2025 Ringer Board, which will begin Tuesday, December 3, 2024. Ringer Board tracks each participant's best league day score on each of the 27 holes from December 3, 2024, through the last league play in November, 2025. Each time a player improves on a hole, that new score is entered. Annual winners will be the ladies with the best net scores, with the number of flights determined by the number of participants.

Theresa will be collecting annual Ringer Board enrollments at the General Meeting, Tuesday, November 12th. It's \$5, there are envelopes on the Lady Niners bulletin board, or just put \$5 in an envelope, with your NAME and date, and place it in the Lady Niners Drawer in the Pro Shop.
